- 3. The cell line(s) and derivatives will not be offered for sale or be utilized in commercial processes, without having secured written agreement with the Biological Bank on behalf of the original depositor
- 4. The cell line(s) will not be distributed to third parties and no alteration will be made to the cell line name or acronym
- 5. The present agreement does not represent transfer of property nor intellectual property rights on the cell line(s) and derivatives; the Biological Bank will not be liable in case use of cell line(s) and derivatives should infringe any intellectual property rights of a third party
- 6. In case the cell line(s) belongs to the Biological Level 2 containment, (d. leg. vo 81/2008), this is clearly specified in the technical sheet; the researcher confirms that he/she has access to adequate laboratories
- 7. The Biological Bank and its depositors do not accept any liability in connection with the handling or use of the cell line(s)
- 8. If the cell lines are referred to in any publication, the ICLC catalogue code will be included, and reference to the original paper will be added, if available in the technical sheet
- 9. The cells (either frozen in dry ice, or in culture as a 25 cm² flask) are shipped on mondays or tuesdays, by express carrier.
